## 1. COLLECTING INFORMATION:

IASA automatically collects and stores information from all users of this website.

**IASA Cookies:** "Cookies" are pieces of data that a website can send to a browser which may be stored on your computer. Many website browsers allow cookies, but you may edit your browser's options to block them. IASA uses cookies on its website to provide basic functionality to the website for purposes such as logging into the system and enhancing access to the features of this website.

**Third-Party Cookies:** Third-party cookies may also be used on this website through advertisements from third parties. IASA is not responsible for the use of information gathered by these third parties.

**IASA Login System:** When logged in, members can access demographic information on themselves. For this reason, if you logged in on a public or shared computer, you should log out or quit the browser when done to promote external privacy.

## 2. USING COLLECTED INFORMATION:

IASA (including its affiliates, agents, contractors, and others with whom it has business relationships) uses collected information for a variety of purposes which may include facilitating the proper functioning of the website and tracking information.

In addition to the uses identified above, IASA uses member information, which may include information collected on the website, for a variety of purposes including:

**E-mails:** IASA sends e-mails to its members for various purposes, including but not limited to, professional development opportunities, programs and services information, member benefit information, and more. **E-Commerce:** IASA allows members to order products and services through this website. Information collected during this process is used to verify membership and bill for the products and services.

### **3. SHARING PUBLIC USER INFORMATION:**
