

## Illinois School Referenda Election Results - April 6, 2021

Results of the April 6, 2021, referenda related to public school districts in Illinois reveal that 13 of the 21 questions, or 62%, were successful and 8 of the 21 questions, or 38%, were defeated. The results of the tax referenda, based on unofficial tallies gatherd by an IASA email survey and internet research, are reported in two sections: successful and unsuccessful. The school districts are listed by IASA Region and then by county within the Region; the county is determined by the location of the district's administrative office.
