



Illinois School Referenda Election Results - March 20, 2018

Results of the March 20, 2018, referenda related to public school districts in Illinois reveal that 14 of the 22 questions or 64%, were successful and 8 or 36% were defeated. The results of the tax referenda, based on unofficial tallies gathered by an IASA email survey and internet research, are reported in two sections: successful and unsuccessful. The school districts are listed by IASA Region and then by county within the Region; the county is determined by the location of the district's administrative office.
